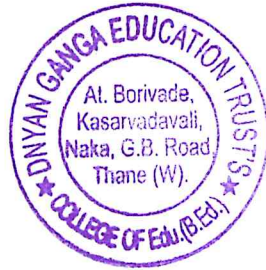
- In addition to offering post-graduation courses such as M.Ed. and M.A. in Education, Trust is also intending to expand its offerings in the field of teacher's education.

- Enhancing campus infrastructure and recruitment procedures.



- A webinar on NEP 2020 was organised by Dnyan Ganga Education Trust's College of Education (B.Ed.) on 27th July 2023.

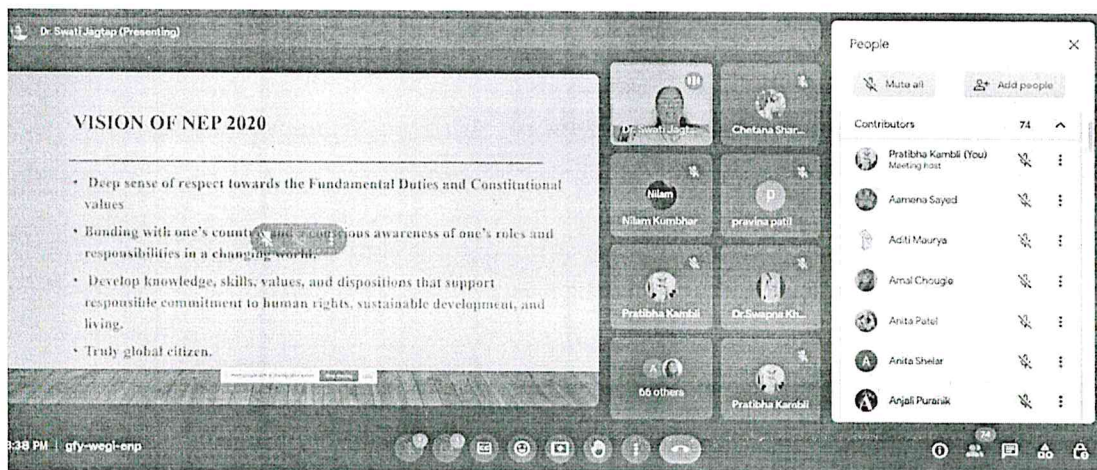



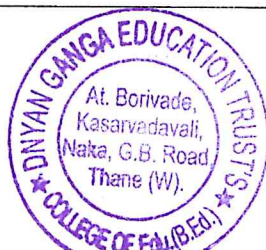

As a part of the ongoing NEP 2020 Week Celebration, Dnyan Ganga College of Education organised a series of intra-college competitions, with the theme being 'NEP 2020'.
